#### 5. QUALIFICATIONS

In accordance with *Article 4: Qualification of Contestant* of the WPT Competition Rules, the contestant must be:

<b>CRITERION #1:</b>	Holder of the nationality of the participating team
<b>CRITERION #2:</b>	An athlete must be the one selected by the WT based on the World Para Taekwondo Ranking published June 2026. The pre-registration information shall be extended to the pertinent member national taekwondo association that is recognized by the World Taekwondo.
<b>CRITERION #3:</b>	Holder of WT recognized Dan or 5-1 Geup
<b>CRITERION #4:</b>	<b>An athlete must be 16 years old or older.</b> An athlete who was born in the year of 2010 or before is eligible to participate in the competition.
<b>CRITERION #5:</b>	Holder of valid WT Global Athlete Licence (GAL). * <i>Any questions on the WT GAL please contact your assigned WT GMS Manager</i>
<b>CRITERION #6:</b>	The athlete has to be classified in the K44 Sport Class with a confirmed "C" or Fixed Review Date "FRD" Sport Class Status with a date after the Rome 2026 World Para Taekwondo Grand Prix

## 6. COMPETITION RULES

The latest World Para Taekwondo (WPT) Competition Rules & Interpretation shall be applied.

## 7. METHOD OF COMPETITION

- i. Single elimination system
- ii. Event Grade: G-6
- iii. Number of athletes: Maximum 12 per weight category.
- iv. Host country: 1 athlete from the host country per K44 weight category shall be additionally invited.
- v. Seeding and drawing of lots: All ranked athletes based on June 2026 World Para Taekwondo Ranking shall be seeded accordingly.
- vi. Host country seeding: The host country quota athlete shall be seeded in 5th place, provided that no athlete from the host country is already seeded within the top four (4).  
In the event that the host country does not utilize the host country quota, the following shall apply:
  - a. If the host country has two (2) athletes selected based on ranking, the host country shall designate which athlete will be seeded in 5<sup>th</sup> place.
  - b. If the host country has one (1) athlete selected based on ranking, that athlete shall be seeded in 5th place.

## 8. CONTEST TIME

Best of 3 system (2 minutes x 2(3) rounds with 1 minute break)

## 9. CONDITIONS FOR PARTICIPATING TEAMS

Round trip airfare and accommodation charges of room and board shall be borne by the participating Member National Association.

- i. All Athletes and Team officials must hold a WT Global Athlete Licence (GAL) or Global Official Licence (GOL) valid for the event.
- ii. National Team Entry will only be accepted through the WT online registration system and registration is only possible with a valid WT Global Licence. Assigned MNA GMS admins will be notified via email once online registration opens. All athletes and officials must be registered under team name "Country Name National Team", for example "Uzbekistan National Team"
- iii. Only the athletes listed on the pre-registration list may be registered.
- iv. Athlete entries submitted after the registration deadline will not be accepted under any circumstances. Changes to weight categories will also not be permitted.
- v. Athletes and team officials registered online may be replaced without penalty before the **close of the pre-registration period**.
- vi. Registration fee will not be charged for cancellation of participation before the **close of the pre-**

**registration period.**

- vii. Registration fee must be paid in full in case of cancellation of participation of selected athletes after the close of the pre-registration deadline or in case of no-show.
- viii. Team officials can hold **ONLY** one position, holding multiple positions (roles) is not allowed.
- ix. Additional Penalty: Penalty of US\$100 per person shall be paid to the Organizing Committee at the accreditation center in the following cases:
  - A team official (any position listed above except for contestants) who is not registered online but seeks accreditation onsite, even if the total number of team officials does not exceed the designated limit.
  - Any team official (any position listed above except for contestants) who seeks to be accredited, online or onsite, exceeding the designated number of entries.
  - Any changes or additions that are made to a team entry list (except for contestants) after the **close of the pre-registration period** will incur a US\$100 penalty. This penalty will be considered the onsite fee for approved changes or additions to the team entry list.
  - Any changes or additions made to a team entry list (except for contestants) after the online registration has closed **MUST** be approved in person by the Head of Team or Manager. If no Head of Team or Manager is registered for the event, then written confirmation from the MNA President, Vice President, Secretary General or GMS Administrator will be required.
- x. Re-print Penalty: Penalty of US\$50 per accreditation shall be paid to the Organizing Committee at the accreditation center for any re printing of accreditation cards due to loss of accreditation.
  - \* **Any WT Global Licence registration completed onsite will incur a US\$50 onsite processing fee per WT Global Licence required.**

**12. ATHLETE SELECTION CRITERIA AND PROCESS**

- i. **Pre-registration Eligibility**  
The top forty (40) athletes per weight category, based on the World Para Taekwondo Ranking published in June 2026 (including all results and deductions until May 31, 2026), shall be eligible to pre-register for the event.
- ii. **Selection of Athletes**  
From among the athletes who have completed pre-registration, the top eleven (11) athletes per weight category, according to the World Para Taekwondo Ranking published in June 2026, shall be selected to participate.
- iii. **Maximum Quota per MNA:** Two (2) athletes per weight category
- iv. **Host Country Quota**  
One (1) additional athlete from the host country per weight category may be invited in addition to host nation athletes qualified through the World Para Taekwondo Ranking.
- v. **Entry Confirmation Timeline**
  - Pre-registration period: June 17-July 1, 2026
  - Notification of selected athletes: July 2, or thereafter
  - Athlete replacement deadline: August 27, 2026 (In the event of withdrawal of the selected athletes)

### 13. ENTRY PROCEDURE AND FEES

Entry fees from participating Member National Associations (MNAs) shall be paid online through the WT Global Membership System (GMS). MNAs must complete registration and pay the applicable entry fees during the designated registration period. No cash payments shall be accepted on-site.

**Only athletes included in the pre-registration list may proceed with registration and payment. If an athlete is not included in the final list of selected athletes, the entry fee shall be refunded.**

Athletes shall not be permitted to compete unless the entry fee has been successfully paid.

- **Entry Fee:** USD 100 per athlete.
- **Pre-registration Period:** June 17, 2026, 17:00 to July 1, 2026, 17:00 (Swiss local time)

### 14. PENALTIES FOR WITHDRAWAL AND NO SHOW

- i. Any confirmed athlete who withdraws from the event for any reason, including medical reasons, within two (2) weeks prior to the Head of Team Meeting, calculated from 00:00 (Swiss time) on the date of the Head of Team Meeting (**August 20 – September 3, 2026**), shall not be eligible to participate in the next World Para Taekwondo Grand Prix event, regardless of their World Para Taekwondo Ranking.
- ii. The same penalty shall apply to any athlete who fails to appear at the competition (“no-show”).
- iii. Any athlete who withdraws after the weigh-in shall be subject to an investigation to determine whether the withdrawal was made in bad faith.  
Bad faith includes, but is not limited to, cases where the athlete had a pre-existing illness or injury that made it unreasonable to expect participation at the time of weigh-in. The burden of proof shall rest with the athlete to demonstrate that the withdrawal was not made in bad faith. In the event of withdrawal, the athlete must be examined and verified by a WT-appointed Medical Doctor.  
If the Investigation Panel determines that the withdrawal was made in bad faith, the athlete may be suspended for up to six (6) months. The athlete and members of the athlete’s entourage may also be subject to an additional Ethics investigation.
- iv. All pre-registered athletes shall apply for an entry visa to the host country in advance. Cancellation or withdrawal due to visa-related issues shall not be accepted as a valid reason for exemption from the above penalties, except for athletes selected as replacements after **July 23, 2026**. In such cases, the above penalty shall apply.

### 15. WEIGH-IN

- i. The general weigh-in for each weight category shall take place one (1) day before its scheduled competition day.
- ii. The random weigh-in of contestants shall take place on the morning of the competition day of their respective weight category, except for the M+80 and W+67 categories. The list of athletes selected for the random weigh-in will be announced on the World Taekwondo Website on the morning of the competition day
- iii. The random weigh-in shall apply to Three (3) contestants per weight category, with a 5% weight allowance as indicated in the table below:

- iv. During the weigh-in, male contestants shall wear underpants, and female contestants shall wear underpants and brassieres.

## 16. CLASSIFICATION OF RESULTS

Medals and prize money shall be awarded to the medalists in each weight category as follows:

<b>1<sup>st</sup> PLACE:</b>	USD 2,000, GOLD MEDAL & CERTIFICATE
<b>2<sup>nd</sup> PLACE:</b>	USD 1,000, SILVER MEDAL & CERTIFICATE
<b>3<sup>rd</sup> PLACES:</b>	USD 500, BRONZE MEDAL & CERTIFICATE

World Para Taekwondo Ranking Points shall be awarded to all participating athletes in accordance with their final standing in the competition and the applicable World Para Taekwondo Ranking Bylaw. Ranking points earned at this event shall be reflected in the World Para Taekwondo Ranking.

## 17. WT-RECOGNIZED TAEKWONDO UNIFORM AND PROTECTIVE EQUIPMENT

- i. **KPNP K2 Protector and Scoring System (PSS)** will be used for the competition.
- ii. Participating contestants are required to wear **WT-recognized Kyorugi competition uniform** and WT-recognized protective equipment. The latest version of WT-recognized manufacturers' list is available at the website of WT (<http://www.worldtaekwondo.org/wtpartners-wt/recognize.html>).
- iii. The Organizing Committee will provide Protector and Scoring System (PSS) to the participating contestants. Participating contestants are required to bring their own groin guards, mouthguard, gloves, sensing socks and shin and forearm guards for their personal use.
- iv. Before entering the field of play, all contestants will proceed to the inspection desk for inspection of their competition uniform and protective equipment. **Any contestant who wears unofficial competition uniform or protective equipment will not be permitted to compete.**
- v. All athletes shall follow the World Para Taekwondo Uniform Specification Guide ([https://www.worldtaekwondo.org/att\\_file/documents/World%20Para%20Taekwondo%20Kyorugi%20-%20Uniform%20Specification%20Guide.pdf](https://www.worldtaekwondo.org/att_file/documents/World%20Para%20Taekwondo%20Kyorugi%20-%20Uniform%20Specification%20Guide.pdf))
- vi. The top has to cover completely the buttocks. However, the bottom of top should be more than 15cm above the knee cap.
- vii. Instant Video Replay (IVR) System will be used.

## 18. IDENTIFICATION OF NPC CODE AND MANUFACTURER

- i. The national flag shall be positioned between 3 cm and 3.5 cm below the shoulder line on the right sleeve.
- ii. The NPC Code shall consist of the three-letter abbreviation of the respective National Paralympic Committee. It shall be printed in black, in bold "Verdana" font, on the back of the upper garment. The NPC Code shall be centered and positioned at least 5 cm above the bottom edge of the upper garment. The size of the NPC Code shall be 30 cm (width) × 12 cm (height).
- iii. Manufacturer identification (name, trademark, logo, or other distinctive sign of the manufacturer) shall be permitted as follows:
  - One (1) identification on the top of the Kyorugi competition uniform, not exceeding 30 cm<sup>2</sup>, positioned between 3 cm and 3.5 cm below the shoulder line on the left sleeve;
  - One (1) identification on the bottoms of the Kyorugi competition uniform, not exceeding 30 cm<sup>2</sup>, positioned above the knee and centred on the right leg;
  - One (1) identification on the Kyorugi belt, not exceeding 6 cm<sup>2</sup>, positioned at one end of the belt.

#### 19. SPONSOR'S IDENTIFICATION

- i. One (1) sponsor identification (logo) shall be permitted on each of the top and the bottoms of the Kyorugi competition uniform.
- ii. Each sponsor identification shall not exceed 50 cm<sup>2</sup> and shall be placed in a location other than those reserved for the WT logo, manufacturer identification, national flag, and NPC Code.

#### 20. MEDICAL CONTROL

- i. The WT Anti-Doping Rules, and where necessary the Code of the World Anti-Doping Agency, shall apply throughout the competitions.
- ii. Compulsory anti-doping tests will be carried out for selected medalists, while random tests will be conducted to the rest of the athletes. The WT and/or WADA may carry out random out-of-competition testing prior to the championships.
- iii. TUE (Therapeutic Use Exemption)  
Athletes who take any substance or medicine listed in the "Prohibited List" of the WT Anti-Doping Rules and Anti-Doping Code of World Anti-Doping Agency (WADA) for therapeutic purposes are requested to submit TUE applications via ADAMS, together with the required medical information. If you do not have an ADAMS account yet, please contact [tue@ita.sport](mailto:tue@ita.sport) to have it set up.

#### 21. HEAD OF TEAM MEETING AND DRAWING OF LOTS

- i. The Head of Team Meeting shall be held one (1) day prior to the start of the competition, on **September 3, 2026**, in the presence of WT officials and representatives of the participating nations.
- ii. At least one (1) representative from each team shall attend the Head of Team Meeting. In the absence of a team representative, the team shall designate a proxy and notify the Technical Delegate or the WT Sport & Event Management Department prior to the meeting.
- iii. The drawing of lots will take place following the completion of the general weigh-in. The draw will be published on the WT website within four (4) hours after the weigh-in.

#### 22. INDEMNITIES

- i. Each respective Member National Association (MNA) shall be responsible for ensuring that all officials and participants are covered by valid travel and medical insurance for the duration of the event.
- ii. Participants without valid insurance coverage shall not be permitted to compete in the competition.
- iii. The Organizing Committee shall obtain general public liability insurance for the event.

#### 23. ACCOMMODATION AND TRANSPORTATION

Participating teams are required to complete the Accommodation Booking Form and return it to **OC designated agency** by no later than August 7. When you submit the booking form the OC will send a confirmation letter with the invoice. All accommodation rates are quoted in KRW and included bed and all taxes, Wi-Fi, airport transfers and shuttle services to the training and competition venue. Please submit the final travel schedule to **OC designated agency** by August 7.

**The contact information of the OC designated agency and accommodation & transportation package will be updated and shared shortly.**

Airport pick-up service will be provided only from August 31 to September 2.

#### **24. VISA INFORMATION**

The Organizing Committee can provide Visa invitation letters for visa applications.

Invitation letter is available for the registered participants upon registration, and it is the responsibility of each athlete and MNA to apply for and secure the correct entry visa for Korea.

Please keep in mind that the process time to obtain a Korean Visa.

#### **25. COACH'S ATTIRE**

All coaches are required to wear formal suit such as tie, jacket, dress shirt (long- or short-sleeved), and trousers, and sport shoes during Semi-Finals and Finals. Caps or hats of any kind shall not be permitted.

Any coach who fails or refuses to comply with the above dress requirements shall not be permitted to coach at the Muju Taekwondowon 2026 World Para Taekwondo Grand Prix and may also be ineligible to coach at the subsequent Grand Prix event.

#### **26. TEAM DOCTOR'S MEETING**

In order to receive an accreditation card, all registered team medical staff shall attend team doctor's meeting on September 3, 2026.
