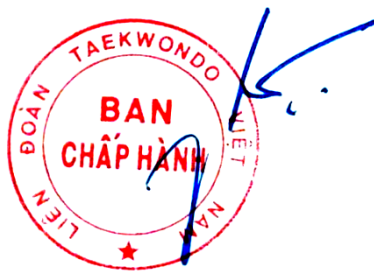

6.4 Holder of the WT Global Athlete License (GAL)

6.5 Contestants who are at least 17 years old in the year 2025

- Each team can send as many athletes as it wishes per weight category to compete in the 1st CJ Viet Nam Open 2025 - World Taekwondo G1.
- Athlete Replacement: In the event that the registered athletes should be replaced by another due to injuries, the participants can officially request to the ATU for the

replacement by no later than June 20th, 2025 by submitting “Athlete Late Replacement Form” together with certification from the medical doctor in the language of the pertinent country and also in English to admin@asiantu.org and GM office@waychamp.vip (c.c. tkdvn1996@gmail.com). The decision on the replacement will be made after evaluation of the submitted documents.

- The coach must obtain WT Level 1

JUNE 26th, 2025: Official Registration and Head & Medical of Team Meeting & Weigh-in

JUNE 27th – 28th, 2025: Competition starts at 08:30 AM

JUNE 29th, 2025: Team Departure

7.1 REGISTRATION & ACCREDITATION:

- The deadline for online registration through the GMS system is June 10th, 2025
- Official Registration: 26th JUNE 2025: 09:00 - 10:00 AM at the Host Hotel (O.C. will arrange transportation from Team Hotel to Host Hotel)
- Registration Fee: 50 USD/athlete, as in Article 8.3.

7.2 WEIGH – IN DATES: 26th - 27th June, 2025: 10:00 PM - 12:00 PM at the Stadium

7.3 HEAD OF TEAM MEETING/MEDICAL TEAM MEETING

The Head/Medical of Team meeting will be conducted on June 26th, 2025, and Jun 27th, at 04:00 - 06:00 PM at the Host Hotel. All information will be published on the following (social) media platforms: <https://bit.ly/3Z39Ntt>

7.4 RANDOM WEIGH-IN: Daily at 07:30 AM, all athletes must be at the Random Weigh-in place in due course.

7.5. Competition dates:

- **June 27th:** Male: Under 54kg, 58kg, 63kg, 68kg; Female: Under 46kg, 49kg, 53kg
- **June 28th:** Male: Under 74kg, 80kg, 87kg, +87kg; Female: Under 57kg, 62kg, 67kg, 73kg, +73kg

8. TERMS AND CONDITIONS OF PARTICIPATION

Members of the team (officials & contestants) and others (supporters) must stay at the hotel arranged by the organizing committee.

8.1. For the safety and security of all participants, participating teams must comply with the instructions given by the City Government and the Organizing Committee during the competition days in Ho Chi Minh City.

8.2. The respective participating teams will bear the round-trip airfare, accommodation, meals, and miscellaneous expenses.

8.3. The Organizing Committee has made a packaged arrangement of **USD 250** per person for this event, which includes:

- Five (5) days, Four (4) nights room with daily breakfast and lunch during ***competition days only*** (dinner not included)
- Check-in : * June 25th, 2025 and Check-out : * June 29th, 2025
- All ground transport (Tan Son Nhat International Airport - Hotel - Stadium - Hotel - Tan Son Nhat International Airport) for the period of the event (*June 25th to 29th, 2025). If you arrive on other dates, please kindly contact the OC for your local information.
- Participation fee for 1 individual kyorugi event

9. COMPETITION RULES

Last updated WT Competition Rules & Interpretation shall be applied

9.1. DRAW SHEETS & BRACKET PUBLICATION

The draw sheets and brackets will be published daily, one (1) day before the start of the competition at 08:00 PM on the following (social) media platforms: <https://bit.ly/3Z39Ntt>

9.2. SEEDING

Senior: All athletes will be seeded according to the last published WT World Ranking

9.3 METHOD OF COMPETITION

The best of three (3) system with the Single Elimination Tournament System will be used.

9.4 CONTEST TIME

Senior divisions: 3 rounds of 2 minutes, 1-minute break between each round

The WT Technical Delegate has the authority to adjust the contest time as he sees fit.

- **IVR – SYSTEM:** IVR is managed **by the KPNP system**.

12. AWARDS

12.1 Individual awards

12.2 Team Awards

Trophies for overall Champion, 1st Runner-up, and 2nd Runner-up will be awarded by medal tally from both male & female free sparring events.

13. ANTI-DOPING

13.1. The WT Anti-Doping Rules, and where necessary, the Code of the World Anti-Doping Agency shall apply throughout the competitions.

13.2. TUE (Therapeutic Use Exemption): Athletes who take any substance or medicine listed in the “Prohibited List” of the WT Anti-Doping Rules and Anti-Doping Code of the World Anti-Doping Agency (WADA) for therapeutic purposes are requested to submit TUE applications via ADAMS, together with the required medical information. If you do not have an ADAMS account yet, please contact tue@ita.sport to have it set up. Otherwise, please download the TUE Application Form [HERE](#) and once duly completed and signed, send it together with the required medical file to tue@ita.sport with a copy to antidoping@worldtaekwondo.org by at least 30 days before the first competition day. 14. WT Technical Delegate (TD): Approved by WT. OC will provide a round-trip air ticket, free accommodation of room and board (Check-in : * June 25th, 2025 and Check-out : * June 29th, 2025), and a daily allowance of US\$200 for two days of competitions.

15. Competition Supervisory Board Members: Three (03) members, including TD. OC will provide a round-trip air ticket, free accommodation of room and board (Check-in : * June 25th, 2025 and Check-out : * June 29th, 2025), and a daily allowance of US\$200 for two days of competitions.

16. International Referees (IRs): OC will invite 15 eligible WT international referees through the WT online international referee management system (IRMS). We will provide free accommodation of room and board (Check-in : * June 25th, 2025, and Check-out : * June 29th, 2025), and a daily allowance of US\$150 for two days of competitions.

17. MEDIA & PRESS

17.1 MEDIA ACCREDITATION

Registered media and press officials or official photographers are entitled to receive a media and press accreditation card. For more information, please contact the Organizing Committee at tkdvn1996@gmail.com

17.2 PHOTO POSITIONS

Accredited photographers can only use the designated photo positions while working in the Field of Play. By accepting a media and press accreditation, the accredited person agrees to follow at all times the instructions of the Organizing Committee.

18. INDEMNITIES

It is the responsibility of each registering team to ensure that their athletes and team officials have filled out the indemnification forms correctly and have duly signed them, thereby indemnifying WT, ATU, the Organizing Committee and all other officials and athletes from any claims of injuries, losses or otherwise arising in the course of participation at 1st CJ Viet Nam Open 2025 - World Taekwondo G1 or any activities linked therewith. It is the responsibility of each registered team to ensure and guarantee that sufficient insurance coverage has been arranged for all athletes, team officials, and other participants. Without sufficient insurance coverage, teams will not be allowed to compete.

Please fill out the Personal Indemnity Forms and return them to the Organizing Committee before 26th June 2025. Each participant (athletes, team officials, etc.) has to fill out the indemnification form.

19. MEDICAL INSURANCE

All participating athletes, coaches, team officials, technical officials and participants at the 1st CJ Viet Nam Open 2025 - World Taekwondo G1 shall have mandatorily an international medical insurance that covers medical care and in case of emergency, repatriation to the country of origin, valid on the days present in the host country of the event. ATU or the Organizing Committee shall be responsible for covering any medical costs incurred for medical treatment before, on, or during the competition

or repatriation in the broadest sense of the word. All relevant documents proving that such insurance is present, including insurance policy papers, should be taken to the event in case a medical situation occurs. Each MNA, Team doctor, or team medical staff must ensure their athletes and team officials have valid international health insurance that covers medical and emergency care at the designated hospitals in Ho Chi Minh City before arrival at the venue.

20. VISA

Visa forms should be sent back to tkdvn1996@gmail.com by the 26th of May, 2025. Forms sent after the 26th of May 2025 will not be accepted for any reason. All wrong information provided (mistakes in names, document numbers, dates, etc.) is your responsibility. To get a visa invitation, you need to send:

1. proof of registration in GMS.
2. Pre-book your accommodation via OC (mandatory)
3. Please refer to the form attached to the event.
4. Please, be informed, in case you do not get a visa on time, your payment is not refundable at any
