**COMPETITION RULES** 

#### KYORUGI

The WT Para Taekwondo Competition Rules as of May 2, 2023 will be implemented for the Para Taekwondo competitions of the K44 Sport Class.

Please note that Article 10.5 of the WT Para Taekwondo Competition Rules will be in effect. Athletes that fail weigh-in shall be disqualified. All athletes are required to be registered in the correct weight division by the end of registration deadline. Weight division will not be changed in the case the athlete does not pass weigh in!

#### **COMPETITION SYSTEM KYORUGI**

#### **KYORUGI**

The competitions in the K44 Sport Class will be held in single elimination tournament system.









## CONTEST TIME

The duration of the contest shall be one round of five (5) minutes with one minute (1) timeout for each athlete. In the case of a tied score after the completion of the five (5) minute round, round of one (1) minute will be conducted as the Golden round, after a one (1) minute rest period. No timeout can be taken during the Golden Round.

Each coach will be allowed to call for one (1) minute timeout at any time during the one round contest.

The duration of contest may be adjusted to four (4) minutes or three (3) minutes upon the decision of the Technical Delegate for the pertinent Championships.

## GENERAL ELIGIBILITY REQUIREMENTS

#### **Qualification System for Paris 2024:**

- According to WT Standing Procedures for the Paralympic Games Article 11 will be in effect for the Europe Qualification Tournament for Paris 2024 Paralympic Games.:
- Article 11.9.6 An MNA, other than the host country, may participate in Continental Qualification tournament as long as:

11. 9.6.1 The athletes' gender and weight categories in the Continental Qualification tournament are not those for which the NPC already obtained a qualification slot through World Para Taekwondo Paralympic Ranking;

11.9.6.2 The number of athletes qualified through World Para Taekwondo Paralympic Ranking of the pertinent

NPC does not exceed the minimum quota of three (3) men and three (3) women places respectively.

• Any country entering the Qualification Tournament must have an IPC recognized NPC.









## ATHLETE ELIGIBILITY REQUIREMENTS

- 1. Holder of a valid 2024 WT Global Athlete License;
- Member of the national team of a pertinent Member National Association, recognized by European Taekwondo Union or World Taekwondo;
- 3. Holder the nationality of the pertinent Member National Association.
- 4. Holder of a Para Taekwondo Dan issued by the WT or a MNA recognized 5-1 Geup
- Athletes must go through International Classification in accordance with the WT Athlete Classification Rules and be assigned a Sport Class and Sport Class Status prior to the tournament.
   Athletes found Net Fligible (NE) will get be able to compete

Athletes found Not Eligible (NE) will not be able to compete.

- 6. An athlete in order to be eligible for participation must be born in 2008 or before for Kyorugi events. All competitors must prove their age by presenting their passport or identification card at the official weigh-in. For those athletes that are not adults, a written consent must be submitted (please find enclosed on the last pages) at the registration, signed by one of the parents or legal guardians, accepting their participation and all parts of the official invitation.
- 7. In case of a Refugee athlete, the athlete must meet following requirements:
  - Must hold the Refugee Status, documented by UNHCR or
  - Refugee Status documented by national agency, e.g. Department of Foreign Affairs or related/responsible department of the residing country
  - Must present the residence status within country in Europe region
- 8. In case of a Individual Neutral Athlete(AIN), the athlete must
  - Obtain AIN Status, screened and confirmed by World Taekwondo
  - Only athlete with AIN GAL Number can participate









## COACH ELIGIBILITY REQUIREMENTS

- 1. Minimum age of 18 years;
- 2. Valid World Para Taekwondo Coach Certificate Level I or above is required;
- 3. Holder of a valid 2024 WT Global Official License;
- 4. Coach is not allowed to wear a Dobok.
- 5. During the semi-finals and Finals all coaches are obliged to wear a formal outfit (suit/dress). During the preliminaries, quarter, coaches shall wear sportswear. Coaches that do not follow the dress code cannot enter the field of play.
- 6. In case of an Individual Neutral Support Personnel participating as a coach must obtain AIN status, screened and confirmed by World Taekwondo. Only coaches with AIN GOL Number can participate.

## MEDAL EVENTS

The European Qualification tournament will qualify the number one (1) athlete in each medal event for the Paris 2024 Paralympic Games.

The following medal events are applicable:

Kyorugi K44 Sport Class

The Para Taekwondo Kyorugi K44 Sport Classes are for athletes with a physical impairment.

#### **PROOF OF PAYMENT REQUIREMENT**

All teams are required to send proof of payment (copy of bank transfer) to <u>office@taekwondo-bulgaria.org</u> within one (1) week after registration in Simply Compete or submit it at the registration appointment booking platform. Taekwondo Europe has the right to delete sport entries from teams that do not send proof of payment from the system in order for other athletes to register and to prevent 'ghost athletes'.

Any athlete registering on-line who does not take part in the competition and who has not been removed from the entry list before the deadline (23rd February 2024), is liable for paying his/her entry-fee in full. (For any athlete not presenting at registration, his/her team or official will be liable for ensuring full payment has been received, prior to the team's participation). If a team does not show up at the event and has not requested a participation cancellation before the deadline, it will be requested to settle the payment of the entry fees in full (100%).

#### **NO REFUND**

European Taekwondo Union and/or the Organizing Committee do not refund entry fees paid.









## **ACCREDITATION CARD DISTRIBUTION**

Registered teams only receive the athlete and official's accreditation cards if all financial obligations have been fulfilled. For all registered athletes, the entry fee has to be paid before the accreditation cards will be distributed to the respective team.

## SPORT EQUIPMENT

KPNP Protector and Scoring System (PSS) will be used at the event.

#### Dobok and protective equipment

## IDENTIFICATION OF NPC CODE AND MANUFACTURER

- National Flag shall be located between 3cm and 3.5cm below the right shoulder on Kyorugi Competition uniform.
- NPC Code must be printed at the back of the upper garment, font of the letters shall be ion bold "Verdana". NPC Code is a three-letter National Paralympic Committee abbreviation, and it shall be printed at the back in black and centered at 5cm or higher from the bottom line of the upper garment within the size of 30cm width x 12cm height.
- Manufacturer's identifications(name, designation trademark, logo or any distinctive sign of the manufacturer) shall be located one for the top within 30cm<sup>2</sup> and between 3 to 3.5cm below the shoulder line of the left arm, one for bottoms within 30cm<sup>2</sup> located above the knee and center of the right leg, and one for Kyorugi belt within 6cm<sup>2</sup> at the end of the belt.
- All participating athletes must wear WT-recognized Kyorugi competition uniform.

## SPONSOR'S IDENTIFICATION

- ONE sponsor's identification(logo) is allowed to each of competition uniform's top and bottoms
- The sponsor's identification shall be located within 50cm<sup>2</sup> except the location of WT logo, manufacturer's identification, national flag, and NPC code.









## FIELD OF PLAY REGULATIONS

By accepting a European Taekwondo Union accreditation card, all accredited persons agree to comply with the Field of Play regulations applicable at ETU events.

## AWARDS

- 1 Gold and Paralympic Ticket for 1<sup>st</sup> place athlete
- 1 Silver for second place athlete
- 1 Bronze medal for the 3rd place athlete
- 1 Certificate for the 4th place athlete

## **ANTI-DOPING**

- i. The WT Anti-Doping Rules, and where necessary the Code of the World Anti-Doping Agency, shall apply throughout the competitions.
- ii. Compulsory anti-doping tests will be carried out for selected medalists, while random tests will be conducted to the rest of the athletes. The WT and/or WADA may carry out random out-of-competition testing prior to the championships.
- iii. TUE (Therapeutic Use Exemption) Athletes who take any substance or medicine listed in the "Prohibited List" of the WT Anti-Doping Rules and Anti-Doping Code of World Anti-Doping Agency (WADA) for therapeutic purposes are requested to submit TUE applications via ADAMS, together with the required medical information. If you do not have an ADAMS account yet, please contact tue@ita.sport to have it set up.

#### INDEMNITIES

It is the responsibility of each registering team to ensure that their athletes and team officials have filled out the indemnification forms correctly and have duly signed them, thereby indemnifying WT, ETU, the Organizing Committee and all other officials and athletes from any claims of injuries, losses or otherwise arising in the course of participation at the European Qualification Tournament 2024 or any activities linked therewith. It is the responsibility of each registered team to ensure and guarantee that sufficient insurance coverage has been arranged for all athletes, team officials and other participants. Without sufficient insurance coverage, teams will not be allowed to compete.

Please fill out the Personal Indemnity Forms and return them to the Organizing Committee before 23<sup>rd</sup> February 2024. Each participant (athletes, team officials, etc.) has to fill out the indemnification form.









## MEDICAL INSURANCE

All participating athletes, coaches, team officials, technical officials and participants at ETU events shall have mandatorily an international medical insurance that covers medical care(COVID included) and in case of emergency, repatriation to the country of origin, valid on the days present in the host country of the event. ETU nor the Organizing Committee shall be responsible to cover any medical costs incurred for medical treatment before, on or during the competition or repatriation in the broadest sense of the word. All relevant documents proving that such an insurance is present, including insurance policy papers, should be taken to the event in case a medical situation occurs.

Each MNA, Team doctor or team medical staff must ensure their athletes and team officials have valid international health insurance that covers medical and emergency care at the designated hospitals in Bulgaria before arrival to the venue.

#### NON EU CITIZENS ENTRY REQUIREMENTS

Due to Bulgarian Government decision all participants at sport event need permission from the Bulgarian Ministry of Youth and Sport to enter in the country. The decision does not apply to the countries members of European Union, Schengen agreement and the following countries: San Marino, Principality of Andorra, Principality of Monaco, Vatican City, The United Kingdom of Great Britain and Northern Ireland, Georgia, Republic of Albania, Ukraine, Republic of North Macedonia, Republic of Serbia, Kosovo, Bosnia and Herzegovina, Montenegro, Republic of Moldova, Israel, Republic of Belarus and Republic of Turkey.

Representatives from other countries not listed above, need to contact: office@taekwondo-bulgaria.org in order to start the process for permission issuance.

The visa procedure is different for every country, please apply as soon as possible.









### INTERNATIONAL REFEREES

World Taekwondo will appoint the International Referees. The appointed international Referees shall officiate at the European Qualification Tournament the following conditions shall apply:

- i. International Referees are required to pay for their own round-trip airfares.
- ii. The Organizing Committee shall cover the expenses for three (3) nights stay of room and board.
- iii. Check in: March 6<sup>th</sup> & Check out: March 9<sup>th</sup>. The Organizing Committee shall pay a per diem of USD \$150 to the selected International Referees for competition period (total 1 day: USD \$150 per referee). The Referee training will take place on March 7<sup>th</sup>, 09:00-18:00

# Guideline on Refugee Athlete For Continental Qualification Tournament Paris 2024 Olympic Games

- 1. The eligible refugee athlete must have official refugee status before the entry deadline of the pertinent continental qualification tournament, meaning that an athlete whose status is in process of examination will not be accepted to compete.
- 2. The refugee certificate issued by either governmental authorities of current residing country or the UNHCR will only be accepted.
- 3. In addition to the certificate, official endorsement letter from MNA of current residing country must be presented.

4. The refugee athletes must have either qualified to international standards in the recent past or have the potential to reach Olympic standard which shall be determine by one of following criteria:

- Be a medal winner (1<sup>st</sup> or 2<sup>nd</sup> or 3<sup>rd</sup> places) at any of the G ranked senior kyorugi competitions enlisted on the WT event calendar between June 1, 2022 and May 1, 2024.

- Be ranked within 20<sup>th</sup> place at least once in the WT World Ranking between June 1, 2022 and May 1, 2024.

- Have advanced to round of 16 or higher at WT World Taekwondo Championships between June 1, 2022 and May 1, 2024.

- Have advanced to quarter-finals or higher at two-year cycle Continental Taekwondo Championships held between June 1, 2022 and May 1, 2024.

- Be the 1<sup>st</sup> place of national taekwondo championships held between June 1, 2022 and May 1, 2024.

\*\* In case the athlete currently resides in a refugee camp, he/she can be exempted from article 3 & 4.

5. To register the refugee athlete, the abovementioned required documents shall be submitted to the WT Sport & Event Management Department (sport@worldtaekwondo.org)
